September10, 2024

President Shirley Leonard called the meeting to order at 7:01 P.M. The meeting was opened with a prayer by Mr. Richardson .The August 13,2024 minutes were read by the attendees. After a motion by Mr. Castex and seconded by Mr. Davenport the minutes were approved. Ms. M. Spates presented the August 2024 treasurer's report. Old Business

Neighborhood Signage: Mr. Castex provided an update on the neighborhood signage. The J & M sign company is willing to replace the 2 neighborhood signs(Buxley and Tidewater and Player and Tidewater). The two offers from J & M are that J & M is willing to re-do the signs and either replace them for \$1100 (\$500 each) or the signs can be redone by J & M for a cost of \$450 each and we replace them ourselves. Mr. Luckett was not present to give a report. The Civic Club members voted today to allow the J & M Sign Company to complete the entire job. Mr. Castex will see Ms. Spates(the treasurer) to get the payment.

Construction issues on Trail Lake- It was noted that the construction project appears to be near completion. Mr. Castex and Mr. Ray noted that some street lights are out and appear to be because of the street construction. These will be addressed when the work is finished. If there are any residual issues, these will be addressed also.

Street Representative Reporting Form

The street representative form letter to be sent to the property owners when issues are found from the monthly street reviews was discussed again. This item was put on hold until the October meeting for further discussion. Ms. Franks asked if the form is available on the Civic Club's website. It is not. Ms. Spates agreed to post the form in English and Spanish on the website.

House Rebuild on Inn shire.

Texas General Land Office Notification(House rebuild on Innshire. S.Leonard reported to the members that a notice and a copy of the design was sent to the Civic Club from the Texas General Land Office regarding the rebuild of a house at 13331 Innshire. The design and notice content were reviewed and acknowledged by Ms. Scurlock and Ms. Leonard with a response that no immediate concerns were recognized. This response included a statement of expectation that the rebuild meet City and all other build standards. A draft copy of that letter was provided to the members on today with no objection to the content. The response will be sent to the Land Office.
